RESOLUTION NO. <u>05-2025</u> TOWN OF WOODBORO, ONEIDA, WISCONSIN, REGARDING DISCONTINUANCE OF A PORTION OF MUSKY POINT ROAD

WHEREAS, a portion of the public right-of-way known as Musky Point Road in the Town of Woodboro, Oneida County, Wisconsin has neither a present nor future use as public right-of-way and it is in the public's interest to vacate and discontinue the same. Said portion of the public right-of-way is legally described as follows and depicted on the attached Exhibit Map:

That part of the platted road lying northerly of Lots 6 through 10, Block E and Lots 1 through 7, Block 6 of the Re-Plat of Musky Point and the First Addition Thereto, Manson Beach, recorded in Volume 5 of Plats on page 35 as Document Number P000241, being part of Government Lot 4, Section 32, Township 36 North, Range 7 East, Town of Woodboro, Oneida County Wisconsin.

And

That part of the platted road adjacent to Block 6 and Block E of the Re-Plat of Musky Point and the First Addition Thereto, Manson Beach, recorded in Volume 5 of Plats on page 35 as Document Number P000241, being part of Government Lot 4, Section 32, Township 36 North, Range 7 East, Town of Woodboro, Oneida County Wisconsin, which lies northwesterly of the following described line:

Commencing at the southeast corner of said Block E, thence along the northeasterly line of said Block E, N55°12'27"W for a distance of 160.00 feet to the PLACE OF BEGINNING. Thence N34°47'33"E for a distance of 35.00 feet to the southwesterly line of said Block 6, and there TERMINATING.

WHEREAS, Wis. Stat. § 66.1003(4) allows proceedings initiated by the Town Board by the introduction of a Resolution declaring that, since the public interest requires it, the whole or any part of any public way, road, street or alley in the Town may be vacated pursuant to the procedures therein.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The Town of Woodboro has no present nor future interest in the public right-of-way described hereinabove; the discontinuance of the public right-of-way shall not result in land locked parcels; the discontinuance will not deprive a landowner or a public school of all access to a highway; and the public interest requires that such portion of said public right-of-way be vacated and discontinued pursuant to the provisions of Wis. Stat. § 66.1003.

2. Pursuant to Wis. Stat. § 66.1005(2)(a), the Town of Woodboro shall release any of its easement rights, if any, in the public right-of-way being vacated.
3. A public hearing on the passage of this Resolution will be held on the 17 day of day of your day, 2025, at the Woodboro Town Hall, located at 8672 Old Highway K Road, Harshaw, Wisconsin 54529, commencing at 6:00 p.m. on said date, which hearing is not less than forty (40) days after the date on which this Resolution was introduced.
4. The Town Clerk shall cause a notice of said public hearing stating when and where this Resolution shall be acted upon to be published as a Class 3 notice under Ch. 985 Stat. and shall further arrange for said notice to be served personally on all of the owners of all of the frontage of the lots and lands abutting upon the public right-of-way sought to be discontinued if said service can be made within the Town; otherwise, copies of said notice shall be mailed to the owner's last known address at least thirty (30) days before the hearing. If any of the public way is located within one-quarter mile of a state trunk highway or connecting highway, a copy of this Resolution shall be submitted to the Secretary of Transportation and the Commissioner of Railroads if there is a railroad highway crossing within the public right-of-way to be discontinued pursuant to Wis. Stat. § 66.1003(8)(a).
5. The matter shall be referred to the Town Plan Commission for its consideration and report before final action by the Town Board.
6. The Town Clerk shall properly post or publish this Resolution as required by law.
The foregoing Resolution was duly adopted by the Town Board of the Town of Woodboro by a vote of 2 in favor and 0 against, on this 20 day of May, 2025.
