April 15, 2026, 5:30 p.m.

Annual Meeting Minutes

Pledge of Allegiance was recited.

Board Members present were: Chairperson Phil Kriesel, Supervisors Bill Rudis and Amanda Pontell, Treasurer Joann Beltz, and Clerk Judy May.

There were 4 residents in attendance.

Meeting was called to order by Chairperson Kriesel at 5:30 p.m. Chair Kriesel confirmed with Clerk May that notices were appropriately posted.

Chair Kriesel read aloud the meeting rules for the annual meeting.

Resident George Beltz made a motion to approve the April 15, 2025, annual meeting minutes. Motion was seconded by resident Tasha May. Motion carried by hand vote. 4 ayes, 0 nays.

Plan Commission member renewal: Resident George Beltz accepted made a motion to accept Phil Kriesel for three more years on the Plan Commission. Tasha May seconded the motion. Motion carried by hand vote. 4 ayes, 0 nays.

Consider Salaries for Town Board Members (Chairman, Supervisors, Treasurer, Clerk), Poll Workers, and Town Hall Janitor. All effective April 2027 and 2028.

- Resident Tom Hablewitz made a motion to increase 5% all salaries annually for 2027 and 2028. Resident Tasha May seconded the motion. Motion carried by hand vote. 4 ayes, 0 nays.

Road Report –

- Chair Kriesel gave a road report including:
 - Annual road inspection was done on 4/20/2026. He read the road report aloud to the audience members. The road report is available on the town's website.
 - Chair Kriesel announced that Bowens resigned from their highway maintenance contract. He suggested splitting the contracts between two contractors.

Annual Financial Report – Clerk May provided a financial report showing expenses in categories for 2025. She reviewed each one and residents were asked if they had any questions or comments related to the financial report. No one asked any questions.

Resident questions: Chair Kriesel asked if anyone has any questions.

- Resident Tasha May asked about the speed limit on Hancock Lake Rd being reduced. Chair Kriesel explained the requirements from the state in order to change speed limits on any town roads. Statutes state 55 mph on town roads. Who will enforce it? He encouraged Tasha to check into it further if she wants to do so. No clear solutions.
- Resident George Beltz asked about concerns with the construction on Hwy 51 and traffic using Oneida/Hancock Lake Rd as a detour. Chair Kriesel spoke to Oneida County about road limits and options to make sure traffic uses the detour routes. No clear solutions.

The date for next year's annual meeting will be held on April 20, 2027, at 5:30 p.m. Resident Tasha May made a motion to accept this date and time. Resident Brandon May seconded the motion. Motion carried by hand vote 4 ayes, 0 nays. Motion carried.
