# Town of Woodboro Board of Supervisors Monthly meeting minutes

Tuesday, August 16, 2022

Pledge of Allegiance was recited.

The regular monthly board meeting was called to order at 6:00 p.m. by Chairperson Phil Kriesel. Chair Kriesel confirmed the agenda was posted in appropriate places and the town's website.

Members present were Chairperson Phil Kriesel, Supervisors Bill Rudis and James Engman, Treasurer Joann Beltz, and Clerk Judy May. There were 7 audience member present. Roll call completed.

Supervisor Rudis made a motion and seconded by Supervisor Engman to approve the Regular Monthly Meeting Minutes from July 19, 2022. Motion carried by voice vote.

Supervisor Rudis made a motion to accept the August 2022 Expenditures as presented. Motion was seconded by Supervisor Engman. Motion carried by voice vote.

Treasurer's Report: Treasurer Beltz reported an adjusted balance of \$928,855.81.

#### **New Business:**

- 1. Anthony Rio- Oneida County representative report. Not present.
- 2. Tourist Rooming House Review-Tanya Roberts, 7625 West Point Dr. Representative was present. Chair Kriesel stated that the town does not have any ordinances related to rooming houses. No action required.
- 3. Election results. Clerk May reported that the town had 239 voters. 34 absentee ballots were returned and processed. She thanked the election workers for their hard work and dedication to serving the town. The next election will be held on Tuesday, November 8<sup>th</sup>.
- 4. Oneida Lake Access Inaccessibility to water on shoreline. Chair Kriesel stated that some town members have gone and used the access. It was reported that there are trees in the way and the chair is going to send Bowens in to clear some brush/trees to create a minimum 10-foot opening. Also, the town will put up a sign to identify the access from the lake side. Supervisor Rudis stated that he thinks the area should be cleared so it is easier to use. The town board agreed to clear some brush/trees and put up a sign.
- 5. Woodboro Lakes ATV Trail. Chair Kriesel stated no action was necessary, but the trail is complete and open. It has been turned over to Oneida County who will turn it over to the ATV club to maintain. Chair Kriesel is meeting next week to determine the construction costs which are expected to be within budgeted funds.
- 6. Public Road and Lake Access Easements for WB-791. Nothing came out of the Plan Commission meeting last night so no action is needed.

#### **Old Business:**

- 1. Town Roads.
  - a. Rambling Lane. Chair Kriesel stated that he spoke to Ted Somer, surveyor, regarding an easement. Resident asked if there have been any updates. Chair Kriesel stated that he is in
