Pledge of Allegiance was recited.

The regular monthly board meeting was called to order at 6:00 p.m. by Chairperson Phil Kriesel. Chair Kriesel confirmed the agenda was posted in appropriate places and the town's website.

Chair Kriesel stated that there is grant monies available for this project to offset some of the costs. Supervisor Engman made a motion to move forward with the Spring Creek Rd. project.
