## **Tuesday, June 21, 2022**

Supervisor Rudis made a motion to approve the liquor license renewals for Alpine of Harshaw and Rondele Ranch. Supervisor Engman seconded the motion. Motion carried by voice vote.
- 4. Crestwood Drive repave. Two bids were received Pitlik & Wick, \$16,775.00 and Musson Brothers, \$19, 895.00. Chair Kriesel stated a Class 1 notice will need to be posted awarding the contract. Supervisor Engman made a motion to accept the Pitlik & Wick bid. Supervisor Rudis seconded the motion. Motion carried by voice vote.
